

# **Privacy Policy**

# 1. Introduction

This Privacy Policy governs the collection, storage, use, transfer, and protection of your personal information when visiting the websites and using the services of GSS ASSETS LTD, which contain links to this document. By using the Company's websites and services, you confirm your acceptance of the terms of this Privacy Policy.

# 2. Collection of Client Information

GSS ASSETS LTD may collect the following categories of Client data, either independently or through its partners:

- Personal Information (Full name, address, email, phone number, etc.);
- Financial Data (Bank account details, transaction history, etc.);
- Website Visit Information (IP address, browser type, cookies, etc.).

### 2.1. Personal Information

Personal data may be requested when registering for the Company's services, participating in contests, or promotional campaigns. The Company collects only the necessary information to provide high-quality services and communicate with the Client. The obtained data may be combined with information from other Company services. The Client has the right to modify or supplement the provided data upon request.

## 2.2. Financial Information

Financial data is provided by the Client to fully utilize the services of GSS ASSETS LTD. This information may be shared with third parties, such as banks, payment systems, and the Company's partners, to facilitate settlements between the Company and the Client.

#### 2.3. Website Visit Information

## 3. Data Storage and Transfer

Client personal information may be shared with branches, affiliates, and partners of GSS ASSETS LTD in different countries to streamline client data management and standardization.

The Company provides Clients with a secure internal communication system, ensuring additional protection for data transmission.

The Client is fully responsible for the accuracy of the provided information. The Company reserves the right to verify data and request supporting documents if necessary for service provision.

## 4. Information Protection

All personal data is stored on secure servers with restricted access. When transmitting sensitive information, such as passwords or banking details, SSL encryption and other security protocols are used.
